BILLING PROCEDURES AND FEE PAYMENT OPTIONS

Tuition fees are billed annually in early January. Your fee account will include tuition fees, distinctives levy and recharge amounts to assist you with budgeting throughout the year. Extra co-curricular recharges will be billed as a separate item. Quarterly statements are issued detailing all payments and charges applicable for the term. You will receive your Annual 2025 Statement in January via email.

FEE PAYMENT

Oxley College has partnered with FACTS Management Australia to offer families a flexible way to manage tuition and other payments throughout the year. All families are required to set up an instalment plan and make payment through the FACTS system.

The College accepts payment for accounts in the following ways:

- Direct debit payment plan using FACTS payment platform by credit card or bank account.
- The College accepts Mastercard, VISA and AMEX.
- There is an annual FACTS administration fee of \$59 for weekly, fortnightly or monthly plans.

A student's enrolment may be suspended where fees remain unpaid after the first day of each term and a payment plan has not been arranged. Two missed direct debits may result in a student's enrolment being suspended and full-term fees will then be payable prior to the recommencement of enrolment.

It is therefore imperative that you contact the Business Manager before the due date if you require an extension to pay tuition fees.

In exceptional circumstances the College may be able to offer short-term assistance in the payment of fees. Please contact the Business Manager prior to the due date if in need of this assistance.

Withdrawal of a student

Parents are to give at least one full term's notice in writing to the Head of College before terminating a student's enrolment. If insufficient notice of termination of a student's enrolment is received, one term's tuition fees are payable in lieu of notice and any enrolment deposits paid are forfeited.

VOLUNTARY CONTRIBUTIONS

Oxley College Building Fund The Building Fund assists financially with acquiring, constructing, and maintaining school infrastructure. Voluntary donations to the Building Fund are tax deductible for amounts of \$2.00 or more.

An amount of \$600 billed annually, will appear on the annual fee statement sent to families in early January.
